Unless specifically agreed otherwise in advance, the fixed prices Probate quote issued by Madden Law includes work for:

- Reviewing the will and getting the Will from a third part or solicitor, if necessary.
- Advising the Executor on the legal requirements to obtain a Grant of Probate in Ireland.
- Advising the Executor on the rights of all Irish beneficiaries, the obligations and scope of the role.
- Getting all Irish accounts and Irish assets of the deceased valued, except property.
- Registration of notification of death for Irish shares and pensions held in the sole name of the deceased.
- Preparing the legal documents and lodging the application in the Probate Office.
- Submitting the application details to Revenue, for Probate purposes.
- Lodging the change of ownership for property in the Property Registration Authority, if applicable.
- Closure of Irish bank accounts held in the sole name of the deceased.
- Transfer of all Irish assets from the name of the deceased into the name of the beneficiaries, excluding shares.
- Preparation of an estate distribution account.
- Payment of funeral costs or the Fair Deal, if required.
- Payment to all beneficiaries named in the Will.

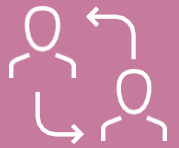

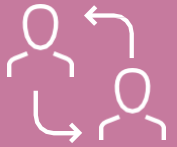
Information in relation to our additional fixed Probate Costs
